

## **International Student Emergency Relief Fund**

Applications opened for the Victorian Government's \$45 million International student Emergency Relief Fund on 19 May 2020.

The fund supports international students in Victoria facing financial hardship through loss of employment due to the coronavirus (COVID-19) pandemic. The fund is delivered through Study Melbourne for the Victorian Government, and in partnership with Victoria's tertiary education providers.

The eligibility criteria and documentation requirements for the fund are outlined on the [Study Melbourne website](#). University and TAFE students can access the fund directly through their [education providers](#). Students enrolled with private education providers can [apply online](#) through the Study Melbourne website.

A number of students at private education providers have also submitted incomplete applications or not supplied the necessary documents. We encourage these students to reapply if their application was incomplete or contained mistakes. There are a range of services in place to help them submit a successful application.

Students at private education providers are also encouraged to follow these tips to make a successful application for the fund.

1. Confirm eligibility before starting. Check the eligibility criteria in the International Student Emergency Relief Fund [Program Guidelines \(Stream Two\)](#).
2. Read the application support information, including the [Application Guide \(Stream Two\)](#) and [Frequently Asked Questions](#)
3. Prepare supporting documents before starting the application. Only JPEG, PDF or PNG formats will be accepted. Learn more about [Preparing supporting documents](#).

4. Use a desktop or laptop computer to do the application, not a mobile device.
5. Check that all information is correct before submitting. If students provide incomplete or incorrect information their application can't be processed.
6. Students can contact Study Melbourne on 1800 056 449 for application support and can also arrange an interpreter if needed.
